Thanks to our dedicated staff and board who waded through the waters to rescue animals, no lives were lost... but the damage to the building forced us to close our doors for nearly a year. Thanks to the tremendous outpouring of community support, we spent this last year rebuilding, while continuing to provide a safe haven for the animals in our care. Today, the inside of our building is finally restored, and we are once again **open to the public** for adoptions.

Products/Services Supplied: The table fee includes one (1) six-foot (6 ft.) table and two (2) chairs. Vendors are responsible for providing their own tent/canopy, signage, displays, and any additional equipment. Payment in full is due at the time this agreement is signed to reserve a space.

Setup & Breakdown: Vendor setup begins at 12:00 PM and must be completed prior to the 1:00 PM event start. Vendors must remain Set up through the 4:00 PM close and are responsible for prompt breakdown and removal of all materials, leaving the space clean.

Cancellation: Table fees are non-refundable within 14 days of the event. Hope4Paws Humane Society reserves the right to decline or remove any vendor whose products, services, or conduct are deemed inappropriate for the event.

Release of Liability, Waiver of Claims, and Indemnification Agreement (New Jersey):

In consideration of being permitted to participate as a vendor at the Hope4Paws Humane Society Open House event, the undersigned Vendor, for themselves, their employees, agents, and representatives, hereby releases, waives, discharges, and covenants not to sue Hope4Paws Humane Society, its officers, directors, employees, volunteers, and agents (collectively, the "Releasees") from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, or injury, including death, that may be sustained by the Vendor, its employees, agents, guests, or property while participating in or traveling to or from this event, to the fullest extent permitted under the laws of the State of New Jersey. The Vendor agrees to indemnify and hold harmless the Releasees from any loss, liability, damage, or costs, including attorneys' fees, arising from the Vendor's participation, whether caused by the negligence of the Releasees or otherwise, except to the extent such claims arise from the gross negligence or willful misconduct of the Releasees. The Vendor further affirms that they carry any insurance required by law for their products, services, or activities and assume full responsibility for their own tent, equipment, and merchandise. This waiver shall be governed by and construed in accordance with the laws of the State of New Jersey. **PHOTOGRAPHIC RELEASE:** Vendor does hereby grant and convey unto Hope4Paws Humane Society all right title and interest in any and all photographic images and video or audio recordings made by the Society during the event, including but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings.
